

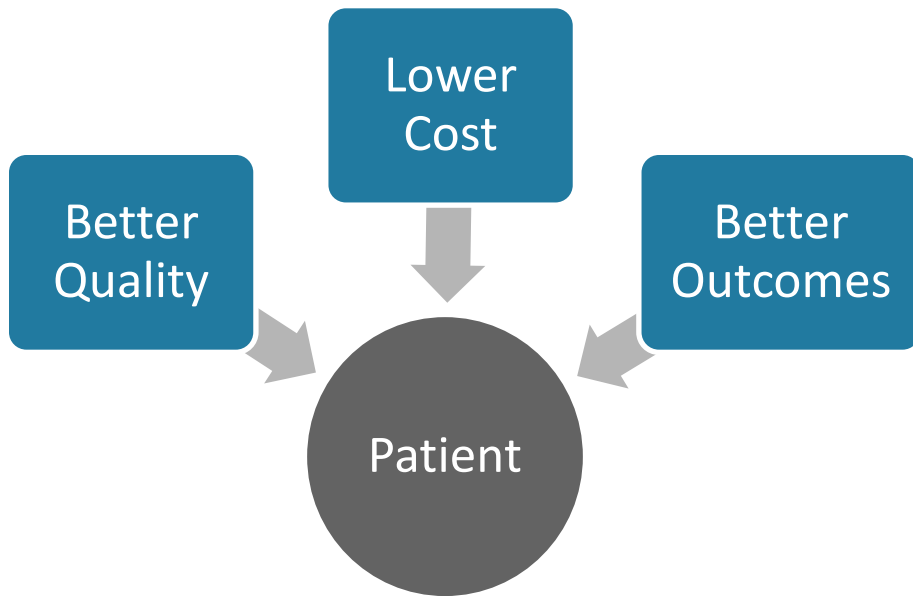

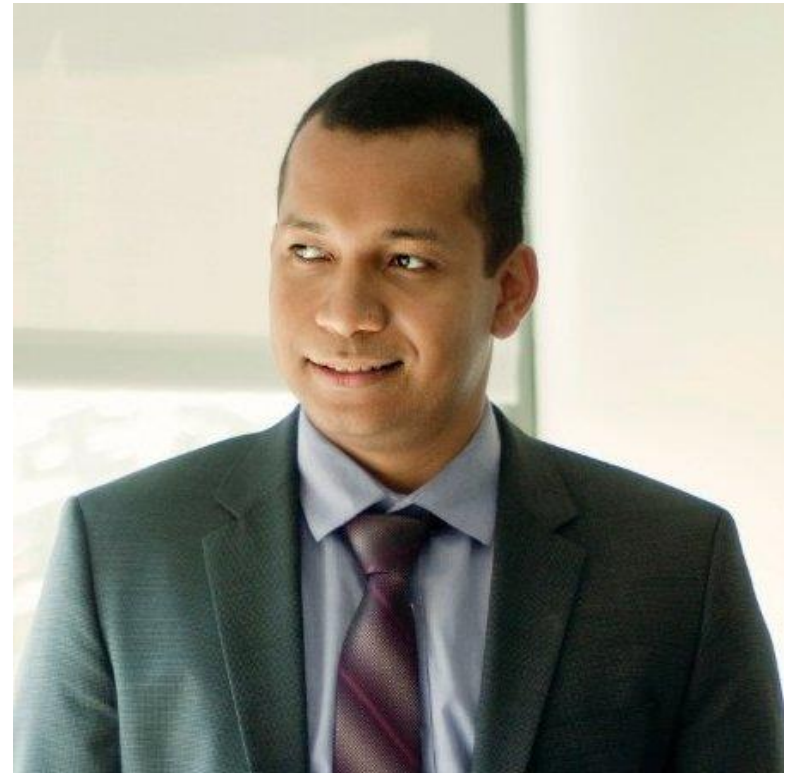

- A Magnet designated facility recognized by the ANCC for quality patient care, nursing excellence and innovations



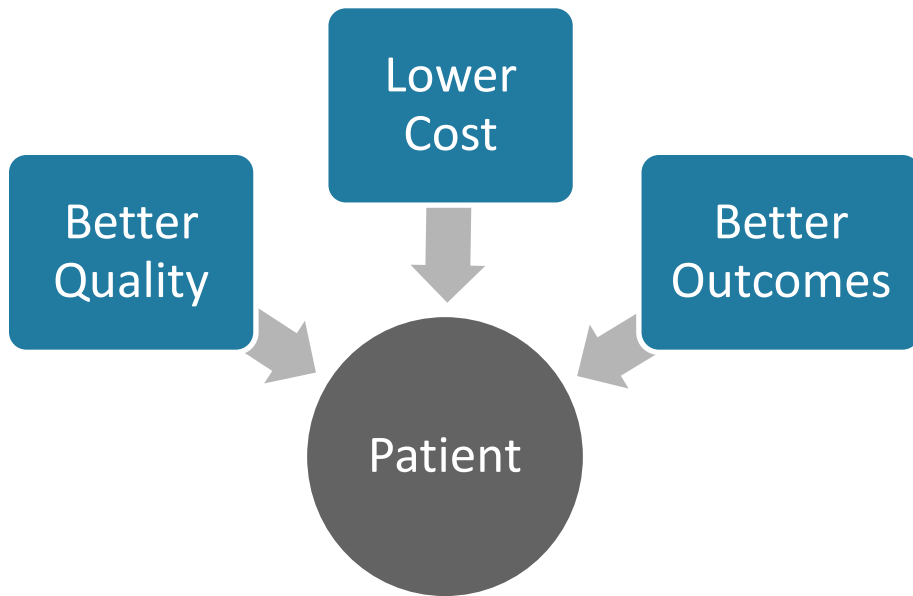
